I understand and acknowledge that I am responsible for my own safety, the safety of other participants, staff and observers, and the safety and security of my possessions for the entirety of my time at Mega Adventure Park.

In the unlikely event of an accident, I acknowledge that you will not be liable for any loss or damage, whether direct or indirect, including but not limited to death or personal injury, and damage to property. I am not pregnant and understand that the Activities are unsuitable for pregnant women and those whose weights fall outside the range of 30kg -140kg.
